TRANSACTION CHARGES FOR RS. 1 CRORE TURNOVER (TOTAL TURNOVER ABOVE 10 CRORE AND LESS THAN RS. 25 CRORE)

BSE AND CSE CHARGES TILL 10 CRORE = $250 * 10 = \text{RS. } 2,500$

SERVICE TAX ON 2500 = $2500 * 12.36\% = \text{RS. } 309$

SEBI CHARGES = RS. 100 ($10 * 10$)

TOTAL FOR 10 CRORE = RS. 2,909 ($2500 + 309 + 100$)

BSE - RS. 50

CSE – RS. 100

SERVICE TAX ON ABOVE ($150 * 12.36\% = \text{RS. } 18.54$)

SEBI – RS.10
